FINAL JUDGMENT

[¶1] Pursuant to the Court’s Order for Judgment, which is incorporated here by reference, it is hereby **ORDERED, ADJUDGED, and DECREED** as follows:

[¶2] Energy Transfer LP shall recover \$879,790.00 in compensatory damages from Greenpeace, Inc. and Greenpeace International jointly and severally.

[¶3] Energy Transfer LP shall recover \$36,722,686.00 in compensatory damages from Greenpeace Inc.

[¶4] Energy Transfer LP shall recover \$21,678,550.00 in compensatory damages from Greenpeace International.

[¶5] Energy Transfer LP shall recover \$21,678,550.00 in compensatory damages from Greenpeace Fund.

[¶6] Dakota Access, LLC shall recover \$879,790.00 in compensatory damages from

Greenpeace, Inc. and Greenpeace International jointly and severally.

[¶7] Dakota Access, LLC shall recover \$62,314,118.00 in compensatory damages from Greenpeace Inc.

[¶8] Dakota Access, LLC shall recover \$21,678,550.00 in compensatory damages from Greenpeace International.

[¶9] Dakota Access, LLC shall recover \$21,678,550.00 in compensatory damages from Greenpeace Fund.

[¶10] Energy Transfer LP shall recover \$41,468,062.00 in exemplary damages from Greenpeace, Inc.

[¶11] Energy Transfer LP shall recover \$10,500,000.00 in exemplary damages from Greenpeace International.

[¶12] Energy Transfer LP shall recover \$10,500,000.00 in exemplary damages from Greenpeace Fund.

[¶13] Dakota Access, LLC shall recover \$74,379,790.00 in exemplary damages from Greenpeace, Inc.

[¶14] Dakota Access, LLC shall recover \$10,500,000.00 in exemplary damages from Greenpeace International.

[¶15] Dakota Access, LLC shall recover \$10,500,000.00 in exemplary damages from Greenpeace Fund.

[¶16] Plaintiffs shall recover 11% interest on the above amounts from Greenpeace, Inc., Greenpeace Fund, and Greenpeace International, starting from the date of the verdict, March 19, 2025, until this judgment is paid.

[¶17] Plaintiffs are entitled to recover costs and disbursements. Plaintiffs shall file a

verified statement of costs within 30 days of this order, pursuant to North Dakota Rule of Civil Procedure 54(e)(1)(A).
